



Sustaining Animal Health and Food Safety in Organic Farming

The organic farming sector has experienced a rapid growth over the past decades. The growth has raised the need to address food safety aspects in relation to animal health, the farm situation and the living conditions of animals. Furthermore, the EU-regulations need to be put into perspectives when food safety is considered.

The objective of SAFO is to improve food safety and animal health in organic livestock production systems through exchange and active communication of research results and conclusions between researchers, policy makers, farmer organisations and other stakeholders, including consumers.

The growth in organic livestock production

In the past decade, the European organic livestock production has experienced rapid growth. Conversion to organic production implies that the whole way of management has to be developed and adjusted to organic principles. This includes emphasising the importance of a systems approach to animal health and welfare protection, and minimizing the use of veterinary drugs. These developments are not always without problems.

Recommended practices in the European

Organic Livestock Standards (EU Regulation 1804/1999) such as closed herds and flocks and improved health security on farms, also include extensive production systems (e.g. free range production) that expose livestock to increased disease challenge.

An EU-funded Concerted Action project, Network for Animal Health and Welfare in Organic Agriculture (NAHWOA) identified in 2001 that organic livestock production faces major challenges with regard to harmonisation and successful integration of organic animal husbandry

dry into the whole organic production system. Major questions about food quality and safety exist, in conventional, as well as organic livestock production. The NAHWOA-network successfully produced a number of recommendations and guidelines on animal health and welfare.

More focus on human health and food safety Consumers' interests, human health aspects, and food safety issues were not covered in the NAHWOA project. There is a urgent need to focus on these aspects and relate them to animal health and the farm situation, the living conditions of animals, and the choices which are necessary to make. Furthermore, the EU-regulations need to be put into perspectives seen from a food safety angle, and the wide diversity between European countries need to be included in the discussion.

In principle, organic standards on livestock production must secure animal health and food safety, they must comply with common EU standards, they should allow farming systems in harmony with their geographic and cultural localities. They should also be the result of a productive discussion between researchers, policy makers, farmers and consumers.



The objectives

The ultimate objective of the SAFO project is to improve food safety and animal health in organic livestock production systems in existing and candidate member countries of the European Union through exchange and active communication of research results and conclusions between researchers, policy makers, farmers and the wider stakeholder community, including consumers.

We achieve this by:

- ▶ Providing a network in which consumer and policy maker concerns about food safety, animal health and welfare in the expanding field of organic livestock production in existing and candidate EU member countries can be addressed.
- ▶ Supporting the process of development and implementation of EU-standards in organic livestock production in the diverse climate of agricultural production systems in the member countries.

The main intermediate objectives of the project are to:

- ▶ Identify important food quality characteristics linked to organic livestock products, and improve food quality, including food safety with regard to zoonoses, drug residues and the development of anti-microbial resistance in the food chain. This objective also includes aspects of food processing quality with regard to animal health and welfare in organic livestock production systems.
- ▶ Develop strategies for implementing and harmonising organic livestock production standards in existing and candidate member countries.
- ▶ Improve the interaction between researchers, farmers, certification bodies and policy makers in order to guarantee the development of organic livestock standards that are driven by inputs from all stakeholders in the EU.

The cornerstone of SAFO is a series of five thematic workshops:

1st SAFO workshop

In early September 2003, the first workshop in the SAFO-network was held in Florence, Italy. The workshop focused on "socio-economic aspects of organic animal production - both on farm level and in a social context".

2nd SAFO workshop

The second SAFO workshop "Development of organic livestock farming: potential and limitations of husbandry practice to secure animal health, welfare and food quality" was held on the 25-27th March 2004, in Witzenhausen, Germany.

3rd SAFO Workshop

The third SAFO workshop was held in Falenty, Poland on the 16-18th September 2004. The workshop theme was "Enhancing animal health security and food safety in organic livestock production systems".

4th SAFO Workshop

The theme for the fourth SAFO Workshop held in Frick, Switzerland on the 17th-19th March 2005 was "Systems development: Quality and safety of organic livestock products".

5th SAFO Workshop

The fifth SAFO workshop, where the conclusions and the recommendations from the project will be presented and discussed, will be held as a part of the Joint European Organic Congress. This congress takes place in Odense, Denmark on the 30 & 31 May 2006. A separate workshop in the SAFO project will be held either 29th May or 1st June (information will appear on our website when the exact date is decided).

The full title of the project is: "Sustaining Animal Health and Food Safety in Organic Farming". SAFO is a European Commission funded Concerted Action Project, Contract QLK5 - CT - 2002 - 02541.

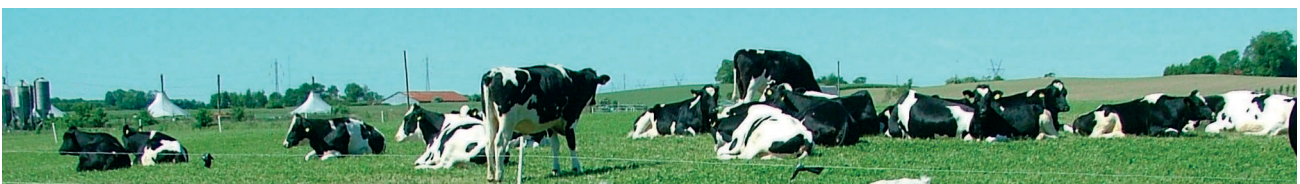
