1. GENERAL INFORMATION

CORE Organic Plus is launching a transnational joint call for research project proposals. Please see the Call Announcement for details on call text, participating countries and funds allocated.

The call is based on funds from participating countries and on an additional funding by the EU. The additional funding of the EU aims at contributing to a more ample selection of projects irrespective of the financial contribution of individual countries by filling in financial short comings.

Research project consortia should apply to one of the four thematic call topics and the maximum duration of the project is 3 years with no possibility for prolongation.

2. FUNDING MODEL

The EU contributes to the ERA-Net with up to 3 million euro. This amount will be used to fund research projects and to fund the call and project administration. A part of the EU contribution has been pre-distributed proportionally to the national contributions. Another part will be used to fill up gaps arising during the selecting of proposals for funding. This will enable full funding of high quality projects according to the ranking list made by a panel of international independent experts, even if national budgets are insufficient. The possibility of closing financial gaps with the EU funds will be a positive advancement for the CORE Organic call.

Applicants in projects that have been selected for funding will receive the grant directly from their national funding body according to their national terms and conditions. The funding will be with contribution from the EU which will be paid via the national funding body. The contribution from the EU for each project partner will only be known after the final selection. The EU funding will always be with the present-day exchange rate from Euro to eventual national currency.

Applicants from countries which are not partners in the CORE Organic Plus or from countries which do not provide funding for a specific thematic area of the call are welcome to participate in the call. However, their costs need to be covered from their own resources or by other sources. They are not taken into account in the minimum requirement of eligible partners and countries in the CORE Organic Plus eligibility criteria.

3. CALL SCHEDULE

The call involves a 2-stage procedure with submission and selection of pre-proposals and, subsequently, invitation of shortlisted consortia to submit full proposals. The respective time schedule and activities required are listed in the table below.

5. SUBMISSION OF PRE-PROPOSALS

The call announcement including this guidance is available at the CORE Organic website: <u>www.coreorganic.org</u>. The pre-proposal application has to be filled in and submitted via the call submission website <u>http://eracall.eu/.</u> **Pre-proposals must be submitted by 25 February 2014, at 13.00 CET**.

For each application, two pre-proposal forms have to be filled in:

1) Part A is web-based and has to be filled in directly on the call submission website, 2) Part B, is web-based and has to be filled in directly on the call submission website,

3) Part C, is web-based and has to be filled in directly on the call submission website and

4) Part D is a project description form and has to be downloaded from- and uploaded to the call submission website.

One application should cover all the project partners of the consortium. It is mandatory to submit the Part D form as an **unprotected** Adobe PDF file. Pre-proposals must be written in English and they should be precise and concise.

Application submission will only be accepted via the CORE Organic Plus call submission website: <u>http://eracall.eu/.</u>

The application should be submitted by the project coordinator on behalf of the consortium (chapter 5.1).

5.1 THE PROJECT COORDINATOR

Each Project Consortium needs to appoint a project coordinator, who, in any commissioned project, has the following role and responsibilities:

• Be the primary point of contact between the CORE Organic Plus Consortium and the researchers on behalf of the Project Consortium from the submission of the pre-proposal until the publication of the



final report.

- Submit the application on behalf of the Project Consortium.
- Compile and submit reports and other deliverables to the CORE Organic Plus Consortium on behalf of the Project Consortium.
- Secure that all project milestones and deliverables are met and take action according to the project management plan if one or more partners fail to deliver.
- Inform the CORE Organic Plus Consortium about any event that might affect the implementation of the project.

The project coordinator will NOT be responsible for the financial management of CORE Organic Plus project funding, which will be handled directly between the national research institutions and their national funding bodies in each participating country.

The coordination costs of a research project have to be specified as eligible costs in the proposal and have to be covered by the funding body of the coordinator. For further information please contact the National Contact Point (Annex A).

5.2 PRE-PROPOSAL APPLICATION

Part A, B and C can be saved at all steps and revisions of Part D can be submitted until the dead-line. The latest version will be shown at the next log-in. On 25 February 2014 at 13.00 CET the latest version is considered to be your final pre-proposal.

6. ELIGIBILITY CRITERIA FOR FUNDING

6.1 ETHICS

Work involving the use of animals or humans should be carried out under the appropriate authorisation taking into account local ethical requirements. Any proposal, which seems to contravene fundamental ethical principles, shall not be selected, and may be excluded from the evaluation and selection procedure at any time by the CORE Organic Plus partners. Judgement of the significance of ethical issues will be made by the partners using the criteria published by the Commission in its guidelines for the Seventh Framework Programme (http://cordis.europa.eu/fp7/ethics_en.html#ethics_sd).

6.2 CORE ORGANIC PLUS ELIGIBILITY CRITERIA

Each project pre-proposal must:

- ✓ Consist of a transnational consortium of at least five independent eligible legal entities from at least five CORE Organic Plus partner countries listed in Annex A.
- ✓ Be written in English.
- ✓ Use the application forms provided via the CORE Organic call submission website: <u>http://eracall.eu/</u>.
- ✓ Fulfil the formal requirements for pre-proposal submission.
- ✓ Be submitted correctly and completely via the call website before the call deadline (25 February 2014, 13.00 CET).
- ✓ The total requested funding for a project partner (or partners from the same country) cannot exceed the indicative amount allocated by their respective national funding body (See Call Announcement).
- ✓ The total requested funding for a project proposal cannot exceed 1.5 million euro

6.3 NATIONAL ELIGIBILITY CRITERIA AND PRIORITIES:

All project partners involved in an application have to assure that eligible costs, sub-contracting, etc. are in line with the respective national regulations. If a funding body has national priorities within a thematic research area, this will be explained in Annex B together with the national main rules and links to the national rules for participants. In case of uncertainties regarding the national regulations or priorities, please contact your National Contact Point (Annex A).

7. SELECTION OF PRE-PROPOSALS

All pre-proposals submitted will be treated strictly confidential by the CORE Organic Plus Consortium. In the selection process at the pre-proposal stage the transnational research proposals which are eligible in terms of



the "Eligibility (criteria) for Funding" mentioned in chapter 6 will be identified. Meeting these criteria is mandatory and pre-proposals that do not meet them will not be considered for funding.

Further, the pre-proposals will be assessed according to the following criteria:

- Relevance of the proposal compared to the call text and current state of knowledge (Innovative and problem solving potential of the project and complementarity with already existing results).
- Soundness of concept and work plan.
- The degree to which the project will overcome/support important barriers/development opportunities for the organic sector
- Quality of consortium in consideration to the European added value (Clear description of the transnational collaboration in the work plan and the European added value of the project being carried out transnationally. A preliminary assessment of the quality of the consortium and geographical coverage of the partnerships compared with the topic).
- Management and budget (Reasonability of the budget in regard to the work plan).

Project Consortia whose pre-proposals meet the eligibility criteria and are assessed to be of high quality on the above mentioned criteria will be invited to submit a full proposal.

In case that one funding body does not support the funding of a pre-proposal for reasons of ineligibility of applicants or national priorities, the whole research project consortium risks not to be invited to submit a full proposal. Therefore, it is highly advisable that the coordinator consult the national priorities and national main rules within the consortium build.

If a country does not wish to fund certain parts of the thematic research area, it will be stated in Annex B and in their national rules.

The CORE Organic Plus Consortium will invite pre-proposal consortia to submit full proposals of an amount of two to three times of the available funds, with due consideration to the geographical coverage and availability of national funding.

Successful and unsuccessful pre-proposal consortia will be informed thereof by the Call Secretariat.

The invitation to submit a full proposal does not implicitly result in the right of getting funded by the CO Plus funding bodies - even if the full proposal gets evaluated positively by the Expert panel.

The full proposals will be evaluated by a panel of international experts and a single ranking list will be prepared covering all four thematic research areas. This ranking list has to be followed by the CORE Organic Plus consortium during the selection of projects.



8. FURTHER INFORMATION

8.1 SUBMISSION OF FULL PROPOSALS

Additional information for the submission of full proposals will be available with the invitations for full proposals and published on the CORE Organic website <u>www.coreorganic.org</u>.

8.2 CONTRACT CONDITIONS

8.2.1 TERMS OF PARTICIPATION

The national funding of the CORE Organic Plus Call is offered under the coordination of the FP7 ERA-NET CORE Organic Plus. Partners of the research project consortia are required to recognize the coordinating role of CORE Organic Plus throughout the duration of the funded research projects until the publication of the final report. Each Research Project Consortium will be asked for a feedback on the processes in order to help to refine them for the future use.

8.2.2 CONTRACTUAL RELATIONSHIPS

CORE Organic Plus is a collaboration between national funding bodies with the aim of establishing transnational research collaboration. The contracts with researchers and funding procedures and regulations remain the full responsibility of the national funding bodies.

Because of the fragmented nature of the funding care will be taken to ensure that the individual contracts are synchronized both in time and content, so that each Project Consortium can deliver transnational outputs as described in the project proposal. The national funding bodies have to ensure that common CORE Organic Plus conditions are met (e.g. common start date of a given project, reporting requirements etc.).

8.2.3 FUNDING CONTRACTS

For the whole duration of the contract it is the responsibility of the Project Coordinator to inform the CORE Organic Plus Consortium (via the Call Secretariat) of any changes which may affect the implementation of the project (e.g. work plan, consortium modifications) and other changes such as changes in the contract details.

Any financial issue is under the responsibility of each national funding body involved in the approved project.

If a change to the Project Consortium occurs which poses a risk to the project, the issue has to be solved by the consortium (in line with the Consortium Agreement, see chapter 8.2.4)). The CORE Organic Plus Consortium must be kept informed of such events.

Any changes in the work plan should be only minor, but will need to be authorised by the CORE Organic Plus Consortium.



8.2.4 CONSORTIUM AGREEMENT

The consortia selected for funding must enter into a Consortium Agreement, in order to manage the project activities, finances, intellectual property rights (IPR) and to avoid disputes which might be detrimental to the completion of the project.

It will be the responsibility of the project coordinators to draw up a Consortium Agreement suitable to their own group. The Consortium Agreement will normally be under the law and legal system of the country of the project coordinator. The purpose of this document is:

- To underpin the project partners' collaboration and provide the project partners with mutual assurance on project management structures and procedures, and their rights and obligations towards one another.
- To assure the funding bodies involved that the Project Consortium has a satisfactory decision making capacity and is able to work together in a synergistic and positive manner.

The Consortium Agreement must be finalized and signed by all partners of the Project Consortium before the official start of the project.

The CORE Organic Plus Call Secretariat will provide the applicants with an example of a Consortium Agreement after the selection process.

8.2.5 INTELLECTUAL PROPERTY RIGHTS, USE AND ACCESS TO RESULTS

Results and new Intellectual Property Rights (IPR) resulting from projects funded through the CORE Organic Plus Call will be owned by the Project Partners according to the conditions stated in their Consortium Agreement and shall not be in conflict with the respective national regulation.

Researchers are encouraged to actively exploit the results of the research project and make them available for use, whether for commercial gain or not, in order for public benefit to be obtained from the knowledge created.

8.2.6 START DATE OF PROJECTS

A project can start when all national contracts have been concluded and all partners have signed the Consortium Agreement. Once the national contracts come into force, eligible national costs may be claimed as per national procedures. Projects should start between 1 January and 1 April 2015.

8.2.7 PROJECT REPORTING

A mid-term and a final scientific report including deliverables have to be sent to the CORE Organic Plus



Consortium by the project coordinator. Project reports and the progress will be assessed against the expected output and timeline as described in the final project description (milestones and deliverables). Action may be taken by funding bodies in case of shortcomings or non-compliance. In addition, brief project updates suitable for immediate publication have to be provided to the CORE Organic Plus consortium annually, and a minimum of 3 stakeholder-oriented articles.

Project reports and articles must be written in English, whereas supplementary versions may also be written in other languages at the Project Partners' discretion and own expenses.

If required by national obligations, each project partner has to report progress of their activity to the national funding bodies. This also applies to financial reports.

8.2.8 DISSEMINATION REQUIREMENTS

Dissemination of project results is requested in the form of various communication routes such as scientific papers, posters, stakeholder involvement, course or training material, web based tools, workshops or direct intervention towards end users. A dissemination plan should be included in the full proposal and specify the planned dissemination activities.

All publications, which originate from the CORE Organic Plus projects, have to be published via the electronic archive, Organic Eprints (<u>www.orgprints.org</u>).

Further, the Project Partners have to acknowledge the transnational funding of the CORE Organic Plus ERA-NET and the individual national funding bodies in any document that is published (in written, oral or electronic form) within the research project.
